Benefits of Collecting
SDOH Data



CMS is focused on increased reporting of social determinants of health (SDOH) diagnosis codes citing this may improve the ability to capture severity of illness, complexity of service, and/or utilization of hospital resources.

These codes are being added to risk methodology and will eventually impact reimbursement. CMS has stated this process will be critical in identifying and addressing health disparities.

Coders look not only to physician documentation, but also to the SDOH "wheel" in Epic documented by other healthcare providers and guidelines allow them to code from here as well.

ICD-10 Z code updates for 2023 (Replacing existing non-specific codes)

Three new codes depict scenarios that may limit a patient's ability to schedule, attend and/ or pay for their medical needs:

- Transportation insecurity (Z59.82) describes issues of inaccessible, inadequate, unaffordable, unsafe, and unreliable transportation.
- Financial insecurity (Z59.86) includes bankruptcy, burdensome debt, and economic strain.
- The inability to obtain adequate childcare, clothing, utilities, and basic needs is covered in material hardship (Z59.87).

Current ICD-10 Z codes already being obtained from this documentation at our hospital

Z55.5 – Less than a high school diploma

Z59.00 - Homelessness unspecified

Z59.01 – Sheltered homelessness

Z59.02 – Unsheltered homelessness

Z59.41 – Food insecurity

Z59.811 – Housing instability, housed with risk of homelessness

Z59.812 – Housing instability, housed, homelessness in past 12 months

Z59.819 - Housing instability, unspecified
