#### **Bundled Payments for Care Improvement – Advanced (BPCI-A)**

#### What is BPCI-A?

- BPCI-A is a value based program that focuses on improving quality by reducing overutilization of services and reducing the overall costs of healthcare. The model is structured to create performance and utilization risk by holding organizations financially accountable for clinical outcomes and avoidable costs.
- BPCI-A includes traditional Medicare Part A and B patients and excludes ESRD patients [in the Renal AKI 0 Bundle], patient who expire on the first IP stay, and managed care plan enrollees.
- BPCI-A program monitors eligible patients from the first day of the IP admission or day of the OP procedure 0 and continues for the duration of the 90 day episode post-discharge.

For 2022 – 2023, St. Tammany Health System has opted into the following 'bundles' or groups of related DRGs (that is determined at time of discharge)

- Acute Myocardial Infarction O CABG
- Cardiac Arrhythmia 0
- Congestive Heart Failure 0
- Cardiac Defibrillator (OP) 0
- PCI (OP) • PCI(IP)


Inpatient Stay (for IP bundles) Day 1: IP Discharge or OP Procedure


